On **Friday, May 8, 2020**, we will be holding our 20th Invitational. Once again, this year the Invitational will be named the Kyle “Toot” Hysack Invitational in honor of our student athlete and member of the Class of 2008 Kyle Hysack that passed away in 2009. This year we will continue the tradition and host an under the lights night meet. We will reserve a rain date of Saturday, May 9th – incase weather cancels the meet, we should be able to get it in on Saturday. Again, the meet will begin at 4:30 on Friday and end under the lights. The cost will be **\$100.00** per team or **\$150.00** per school if you send both your boys and girls teams. We are trying to find a FAT timing group more information will be forthcoming. There will be awards given for the top eight places in each event, trophies given for athlete of the meet, top track performer, and top field performer, and the Kyle Hysack Will-To Win Athlete Award as well as trophies to the top 3 teams.

On **Friday, May 22, 2020**, we will be holding our 20th Modified Invitational. This event begins at 4:30. The cost will be **\$100.00** per school. There will be ribbons for the top 6 places in each event. Trophies will be given to the top 3 teams and to a male and female athlete of the meet.
